Note: An extra Homestay fee of \$3360 will be required for students staying in NZ over the December/January holidays. For students leaving over this period but coming back to their homestay family a \$700 holding fee will apply. For special dietary requirements an extra \$20 per week might apply. A contingency fee of \$250 will apply for 1 and 2 terms, and of \$500 for 3 and 4 terms. This fee is refundable if not used.

Accommodation Monitoring Fee: DCG NZ\$350

Any overpayment of homestay fees will be refunded at the end of the student's schooling.

Insurance:

Insurance is compulsory under Immigration NZ regulations. We can organise comprehensive insurance for our students. More information on this is available upon request. Other policies held by students, must comply with the New Zealand regulations.

Refunds:

The school will consider all requests for a refund of international student fees on a case by case basis. **Note:** Fees are in New Zealand dollars and include New Zealand tax (GST).
